You have been invited to participate in this study because you are a GP contactable through the Royal Australian College of General Practitioners (RACGP) or other networks such as PHNs.

4. What will the study involve for me?

If you decide to participate in this study, you will be asked to answer an online survey which should take approximately 10 minutes to complete. Questions will be asked about your demographic background, your experience of supporting women with breast cancer, and your understanding of other allied health services that are available to support women with breast cancer.

5. Can I withdraw once I've started?

Participating in this study is optional and you do not have to take part. Your decision will have no impact on your current or future relationship with the researchers or anyone else at The University of Sydney.

By submitting your survey, you are consenting to participate part in the study. You have the option to withdraw any time before submitting. Once your responses are submitted, we won't be able to tell which one is yours. This means you cannot withdraw after submitting the survey.

6. Are there any risks or costs?

Aside from giving up your time, we do not expect that there will be any risks or costs associated with participating in this study.

7. Are there any benefits?

There are no direct benefits for you as a participant in this study. However, we can anticipate potential benefits for the future of GP practice and the support of breast cancer survivors.

8. What will happen to information that is collected?

By giving your consent, you agree to us gathering anonymous information about you for this study.

Any information you share us will be securely stored. We plan to publish the findings of this study. You will not be identifiable in these publications. Survey responses will be coded and downloaded to a statistical program for analysis.
